The teepee cover is essentially a series of triangular panels that, when joined, form a cone. You'll typically need 4-6 panels, depending on the fabric width and desired diameter.

The most straightforward method involves:

1. **Calculating the Radius:** Divide your desired base diameter by 2.
2. **Determining the Slant Height:** This is the length of the sloping side of your triangular panels. It's usually the desired height of your teepee plus a little extra for overlap and securing to the ground. Using a right-angle triangle and Pythagorean theorem ($a^2 + b^2 = c^2$) where 'a' is the

height and 'b' is the radius, you can calculate the slant height ('c').

3. **Laying Out the Fabric:** You can either cut a large circular piece of fabric and then cut it into wedge-shaped panels, or cut individual panels. For a beginner, cutting individual panels is often easier.
4. **Cutting the Panels:** Each panel will be a long, isosceles triangle. The base of the triangle is the width of the fabric multiplied by the number of panels, divided by the total number of panels needed to achieve your desired circumference. The two equal sides of the triangle will be your calculated slant height. You'll need to account for seam allowances (typically 1/2 inch to 1 inch) along all edges.
5. **The Apex:** The top of the panels will meet at the apex. You may need to cut a small circular piece to reinforce this area or simply overlap the fabric securely.
6. **The Base:** The bottom edge of the teepee will be reinforced and likely have grommets or loops for staking.
7. **The Door Opening:** Decide on the size and placement of your door opening. This will require additional reinforcement and potentially a flap.
8. **The Smoke Flap:** This is a critical and often overlooked element. It's essentially two triangular flaps at the top of the teepee that can be adjusted with poles to control ventilation and smoke escape.

Adding Reinforcements

2. **Base:** Fold the bottom edge over twice to create a strong hem. You can then install heavy-duty grommets or create sturdy fabric loops along this hem for staking. Spacing them every 12-18 inches is typical.
3. **Doorway:** The doorway needs to be reinforced with a strong hem and potentially with bias tape. Some designs incorporate a flap that attaches to the doorway opening.
4. **Smoke Flap:** This is a more advanced feature. It involves creating two adjustable flaps at the top of the teepee, controlled by poles. The exact construction will depend on your chosen design, but it typically involves creating reinforced pockets for the poles.

Finishing Touches

Once the main seams are sewn, finish any raw edges with a serger or by folding and stitching them to prevent fraying. If you plan to add decorative elements or tie-backs for the smoke flaps, now is the time.

Setting Up Your Teepee

Erecting the Pole Frame

Adjusting for Ventilation
