However, if the investments were different (e.g., \$10,000 in Stock A, \$5,000 in Stock B, \$2,000 in Stock C), the weighted average would accurately reflect the average price paid per share across the entire portfolio, considering the differing quantities.

Geometric Mean: For Growth Rates and Ratios

The geometric mean is particularly useful when dealing with percentages, rates of change, or values that are multiplied together. It's calculated by multiplying all the numbers in a dataset and then taking the n-th root of the product, where 'n' is the count of numbers.

The formula for the geometric mean (GM) is:

$$GM = \sqrt[n]{x_1 \cdot x_2 \cdot x_3 \cdot \dots \cdot x_n}$$

This can also be written as:

$$GM = (\prod_{i=1}^n x_i)^{1/n}$$

Example 6: Average Investment Growth Rate

Suppose an investment grows by 10% in year 1, 20% in year 2, and declines by 5% in year 3. What is the average annual growth rate?

First, convert the percentages to growth factors (1 + growth rate):

1. Year 1: $1 + 0.10 = 1.10$
2. Year 2: $1 + 0.20 = 1.20$
3. Year 3: $1 - 0.05 = 0.95$

Now, calculate the geometric mean of these growth factors:

$$GM = \sqrt[3]{1.10 \cdot 1.20 \cdot 0.95}$$

$$GM = \sqrt[3]{1.254}$$

$$GM \approx 1.0783$$

To convert this back to a percentage growth rate, subtract 1: $1.0783 - 1 = 0.0783$, or 7.83%.

The average annual growth rate is approximately 7.83%. Using the arithmetic mean $(10\% + 20\% - 5\%) / 3 = 8.33\%$ would overestimate the actual average growth over the period.

Harmonic Mean: For Rates and Ratios (Inverse Relationships)

The harmonic mean is typically used when averaging rates, such as speeds or prices, where the quantities are inverted. It is calculated as the reciprocal of the arithmetic mean of the reciprocals of the data points.

The formula for the harmonic mean (HM) is:

$$HM = \frac{n}{\frac{1}{x_1} + \frac{1}{x_2} + \frac{1}{x_3} + \dots + \frac{1}{x_n}}$$

Or, using summation notation:

$$HM = \frac{n}{\sum_{i=1}^n \frac{1}{x_i}}$$

Example 7: Average Speed Over a Distance

Suppose you travel 100 miles at 50 mph and then return the same 100 miles at 75 mph. What is your average speed for the entire round trip?

Time for the first leg = $\frac{\text{Distance}}{\text{Speed}} = \frac{100 \text{ miles}}{50 \text{ mph}} = 2 \text{ hours}$

Time for the return leg = $\frac{\text{Distance}}{\text{Speed}} = \frac{100 \text{ miles}}{75 \text{ mph}} = 1.33 \text{ hours}$

Total distance = 100 miles + 100 miles = 200 miles

Total time = 2 hours + 1.33 hours = 3.33 hours

Arithmetic average speed = $\frac{50 + 75}{2} = 62.5$ mph. This is incorrect because it doesn't account for the different amounts of time spent at each speed.

Using the harmonic mean of the speeds:

$$HM = \frac{2}{\frac{1}{50} + \frac{1}{75}}$$

$$HM = \frac{2}{\frac{3}{150} + \frac{2}{150}}$$

$$HM = \frac{2}{\frac{5}{150}}$$

$$HM = 2 \cdot \frac{150}{5} = 2 \cdot 30 = 60 \text{ mph.}$$

The correct average speed for the round trip is 60 mph. This is because you spend more time traveling at the slower speed, which pulls the average down.
