He proposed that for any naturalistic definition of "good" (e.g., "good means pleasure"), it is always an open question whether that definition is, in fact, correct. We can always coherently ask, "But is pleasure itself good?" If the answer were trivially "yes" because "good" simply *meant* "pleasure," then the question would be meaningless. The fact that we can meaningfully ask this question, Moore argued, demonstrates that "good" cannot be reduced to any

natural property. It is a simple, unanalyzable, and non-natural property.

This insight had profound implications. It meant that ethical judgments, for Moore, were not descriptive statements about the world in the same way that scientific statements are. They pointed to a unique, *sui generis* property that could only be apprehended through a direct, intuitive moral awareness. This non-cognitivist tendency, though Moore himself was a cognitivist (believing moral judgments express beliefs), laid crucial groundwork for later non-cognitivist theories.

The Rise of Non-Cognitivism: Emotivism and Prescriptivism

Moore's insistence on the irreducibility of "good" opened the door for theories that denied that ethical statements express beliefs about moral properties at all. The most influential of these were emotivism and prescriptivism.

Emotivism: The Boo-Hooray Theory

Emotivism, famously articulated by A.J. Ayer in *Language, Truth and Logic* and later refined by C.L. Stevenson, took Moore's critique of naturalism to its logical conclusion. Emotivists argued that ethical statements are not truth-apt; they do not express propositions that can be true or false. Instead, they express the speaker's attitudes or feelings towards a subject. A statement like "Murder is

wrong" was interpreted as analogous to saying "Boo, murder!" or expressing a strong disapproval. Conversely, "Kindness is good" might be akin to "Hooray for kindness!"

While this "boo-hooray" caricature can be misleading, the core idea was that moral language functions primarily to influence the attitudes and actions of others. Emotivists believed that moral disagreements were not disagreements about facts, but rather about conflicting attitudes. This offered a powerful explanation for the seemingly unresolvable nature of many ethical debates. The legacy of Moore is evident here in the rejection of a definitional approach and the search for an alternative account of moral language's function.

Prescriptivism: The Imperative of Morality

R.M. Hare, building on the work of his predecessors, developed prescriptivism, which offered a more sophisticated account of moral language. Hare argued that moral judgments are not merely expressions of emotion but are fundamentally **prescriptive** or imperative in nature. When we say "X is good," we are, in effect, recommending X and implying that others ought to act in a certain way with regard to X.

Prescriptivism distinguishes between **descriptive** and **prescriptive** uses of language. While words like "red" are primarily descriptive, moral terms also carry a prescriptive force. Crucially, for Hare, moral judgments are

universalizable. If you say "You ought to keep your promises," you are committed to saying that anyone in a similar situation ought to keep their promises. This aspect of prescriptivism, its focus on universalizability, was a significant contribution to metaethical thought, offering a rational basis for moral discourse even without recourse to objective moral facts.

The Revival of Realism: Defending Objective Moral Truths

While non-cognitivist theories flourished in the wake of Moore's critique, not all philosophers abandoned the idea of objective moral truths. Indeed, Moore's own metaethics, while rejecting naturalism, was a form of moral realism, albeit a non-naturalist one. He believed in the existence of objective, intrinsic moral properties that are simply apprehended, not defined.

Cornell Realism: Natural Properties as Moral Properties

In the late 20th and early 21st centuries, a new wave of moral realists emerged, seeking to reconcile the insights of metaethics with a robust conception of moral objectivity. Cornell Realism, associated with thinkers like Richard Boyd and Peter Railton, attempted to revive naturalism in a way that avoided Moore's open-question objection. They argued that certain natural properties

are moral properties, not in the sense that they are reducible to them through definition, but in a more robust, scientific sense.

Boyd, for example, drew an analogy with scientific properties. The property of "being water" is identical to the property of having the chemical composition H_2O . While we might initially identify water through its observable properties (clear, liquid, etc.), scientific investigation reveals its underlying nature. Similarly, Cornell realists propose that moral properties (like "goodness" or "rightness") are causally efficacious properties that are intrinsically linked to certain natural properties that have historically played a role in our moral practices. They suggest that a scientific understanding of human psychology, social structures, and well-being can reveal what these underlying natural properties are.

Railton's influential work on "moral luck" and the development of a "naturalistic account of value" also grappled with the challenge of grounding morality in a way that is compatible with a scientific worldview. He argued that value can be understood in terms of what an idealized, fully informed rational agent would desire.

The Pluralist Turn: Multiple Moral Properties

More recent developments in moral realism have embraced a form of pluralism, suggesting that there might not be a single, monolithic property of "goodness" or

"rightness." Thinkers like Derek Parfit have argued for the existence of multiple, irreducible moral properties or reasons. This move acknowledges the complexity of moral experience and the difficulty of finding a single unifying account.

The impact of Moore is palpable in these realist revival attempts. They all, in some way, engage with his critique of reductive naturalism and his insistence on the sui generis nature of moral properties, even if they ultimately seek to ground these properties in a way that Moore might have found problematic.

The Enduring Relevance of Moore's Questions

More than a century after the publication of *Principia Ethica*, the questions G.E. Moore posed remain central to metaethical inquiry. His insistence on distinguishing the *is* of descriptive facts from the *ought* of moral imperatives, his challenge to reductive definitions of ethical terms, and his exploration of the nature of moral judgment continue to frame contemporary debates.

Even contemporary neo-Aristotelian virtue ethicists and constructivists, who may not explicitly reference Moore, are implicitly engaging with his legacy. They grapple with how to establish the validity and authority of moral claims in a world where traditional religious or metaphysical

foundations have been questioned. The debate between cognitivism and non-cognitivism, the nature of moral language, the possibility of moral knowledge, and the grounding of ethical principles – these are all areas deeply shaped by Moore's pioneering work.

The field of metaethics after Moore is characterized by a vibrant, ongoing dialogue. While few contemporary philosophers would fully endorse Moore's specific formulations of non-naturalist intuitionism, his foundational critiques and the conceptual space he opened up have ensured his enduring presence. The quest for a satisfactory understanding of morality's nature – whether it is grounded in objective properties, subjective attitudes, or prescriptive imperatives – is a testament to the lasting power of G.E. Moore's philosophical legacy.
