4. **Determine Good Moral Character:** Certain questions probe your adherence to U.S. laws and your overall conduct, ensuring you meet the "good moral character" requirement for citizenship.
5. **Confirm Eligibility:** The officer will ensure you meet all statutory requirements for naturalization, such as residency, age, and physical presence.

The Three Pillars of the US Citizenship Interview: English, Civics, and Application Review

The interview can be broadly categorized into three main areas, each with its distinct set of questions.

1. English Language Proficiency Test

The English test is integrated into the interview. The officer will assess your speaking and reading abilities through the conversation itself and specific tasks.

Speaking Skills:

The entire interview is an assessment of your speaking skills. The officer will observe:

1. Your ability to understand their questions.

You will be asked to write one out of 10 randomly selected sentences from a list. These sentences are also designed to test your basic writing skills in English.

3. "The United States is a country."

Tips for Writing Skills: Practice writing these sentences, paying attention to spelling, grammar, and punctuation. The officer will be looking for basic accuracy.

2. Civics Test

The civics test assesses your knowledge of American history, government, and geography. You will be asked up to 10 questions from a list of 100 possible questions. To pass, you must answer at least 6 questions correctly. For applicants aged 50 or older who have been lawful permanent residents for at least 15 years (50/15 exception) or aged 55 or older who have been lawful permanent residents for at least 55 years (55/15 exception), the civics test may be conducted in their native language by an interpreter, though English proficiency is still assessed through the interview conversation.

Common Civics Question Categories:

1. **American Democracy:** Principles like rights, responsibilities, and the structure of government.

2. **System of Government:** Branches of government, roles of elected officials, and the Constitution.
3. **U.S. History:** Key historical events, figures, and foundational documents.
4. **Geography:** Important landmarks, states, and regions.
5. **Civic Virtues and Symbols:** The flag, national anthem, and core values.

Examples of Civics Questions:

1. "What is the supreme law of the land?" (Answer: The Constitution)

3. **Practice with Others:** Have a friend or family member quiz you.
4. **Understand, Don't Just Memorize:** While memorization is key, understanding the context behind the answers will help you recall them and answer related questions confidently.
5. **Be Prepared for Variations:** While the core answer is important, be aware that the officer might ask the question in a slightly different way.

3. Application (N-400) Review and Personal History Questions

This is the most extensive part of the interview. The USCIS officer will go through your N-400 application line by line to verify the information you provided and to ask clarifying questions. This section aims to confirm your eligibility and ensure you have been truthful throughout the application process.

Key Areas Covered in Application Questions:

1. **Biographical Information:** Name, date of birth, place of birth, family details.
2. **Residency and Travel:** Dates and durations of your stays in the U.S. and any trips outside the U.S.
3. **Employment and Education:** Your work history and schooling.
4. **Marital History:** Information about current and previous marriages, including details about divorce or death of a spouse.
5. **Children:** Information about your children, including their names, dates of birth, and places of birth.
6. **Moral Character Questions:** These are critical and are designed to uncover any issues that might disqualify you from citizenship.

4. "Have you ever ordered, incited, called for, assisted, or otherwise participated in the killing of any person?"
5. "Have you ever belonged to or been associated with any totalitarian, Communist, anarchist, or terrorist organization?"

Crucial Note: If you have any arrests, even if charges were dropped or you were found not guilty, you **MUST** disclose them and

bring all relevant court documents to your interview. Failure to do so can be considered a misrepresentation.

Immigration Violations and Misrepresentation:

1. "Have you ever claimed to be a U.S. citizen?"
2. "Have you ever filed for a U.S. visa or entered the U.S. as a crewman?"
3. "Have you ever been a J-1 visa holder?"
4. "Have you ever been excluded or deported from the U.S.?"
5. "Have you ever been ordered removed from the U.S.?"
6. "Have you ever helped anyone to enter the U.S. illegally?"

Taxes and Financial Obligations:

1. "Have you filed federal, state, and local income tax returns every year you were required to?"
2. "Have you paid all of your taxes?"
3. "Are you currently behind on any child support or spousal support payments?"

Military Service:

1. "Have you ever served in the U.S. Armed Forces?"
2. "Have you ever deserted from the U.S. Armed Forces?"

Other Important Questions:

1. "Do you support the Constitution and form of government of the United States?"
2. "What is your current marital status?"
3. "What is your spouse's name and date of birth?"
4. "How many times have you been married?"
5. "Do you have any children?"
6. "Where do you live now?"
7. "What is your current employment?"

Tips for the Application Review:
