6. **Synecdoche:** A figure of speech in which a part is made to represent the whole or vice versa. "All hands on deck" (hands representing sailors).
7. **Metonymy:** A figure of speech in which a thing or concept is referred to by the name of something closely associated with that thing or concept. "The crown" (representing the monarchy).
