2. If you know the adjacent and hypotenuse, **$\theta = \cos^{-1}(\text{Adjacent} / \text{Hypotenuse})$**
3. If you know the opposite and adjacent, **$\theta = \tan^{-1}(\text{Opposite} / \text{Adjacent})$**
