By prioritizing evidence-based reforms, investing in dedicated juvenile justice systems, and focusing on genuine rehabilitation, we can build a safer and more just future for both our youth and our communities. The "fish out of water" analogy, when applied to this grim reality, serves as a powerful reminder that we are failing our youngest and most vulnerable offenders, with devastating consequences for all involved.
