The initial German plan for a swift victory, the Schlieffen Plan, failed. German forces were halted by the French and British at the First Battle of the Marne in September 1914. This marked the beginning of **trench warfare**, a brutal and static form of combat

that would define much of the Western Front for the next four years.

Life in the Trenches

Soldiers on both sides lived in a network of ditches, barbed wire, and defensive structures.
