Linear tactics dictated that soldiers fight in lines, typically three ranks deep. The front rank would fire, then step to the rear to reload while the second rank fired, and so on. Drills involved complex movements like "Forming line from column," "Forming column from line," "Wheeling by the right (or left) by platoons," and "Countermarch." These were not simple marching steps; they involved subtle shifts in pace, precise alignment, and clear communication through bugle calls or shouted commands. The ability to form a solid battle line quickly, to shift the front of the line to face a new threat, or to

retreat in good order without breaking formation was critical. **Infantry maneuver** was a learned skill, honed through countless hours of practice under the watchful eye of drill sergeants.

Baron von Steuben's arrival in 1777 marked a turning point. He was a Prussian officer with extensive experience in European military discipline, and he tirelessly drilled the Continental Army at Valley Forge. collective roar of a volley all contributed to a sense of unity and invincibility. The exercise of arms fostered a sense of belonging and shared purpose, crucial for morale in the face of hardship and defeat. It was through these drills that the Continental Army transformed from a ragtag collection of individuals into a cohesive fighting force capable of challenging the might of the British Empire. The concept of **military discipline** was the invisible force that held the physical exercise together.
