While Postman's analysis was primarily focused on television, its relevance has only intensified in the age of the internet and social media. The digital landscape represents an exponentially more pervasive and unfiltered conduit for information, and therefore, for the potential "disappearance of childhood."

Social Media's Role in Blurring Boundaries

Social media platforms are arguably the most significant evolution of Postman's concerns.
