The most probable scenario is that it emerged from a confluence of factors: a desire for rapid weight loss, the inherent simplicity and affordability of its main ingredient, and its subsequent widespread dissemination through anecdotal channels and, more recently, the internet. It is a prime example of a popular diet that gained traction through sheer adoption rather than through the deliberate creation and endorsement of a recognized authority.

While the Cabbage Soup Diet might offer a fleeting glimpse of reduced numbers on the scale, its extreme nature, nutritional deficiencies, and unsustainable results make it a risky and ultimately ineffective approach to health and weight management. For those seeking lasting results and improved well-being, consulting with a registered dietitian or healthcare professional to develop a personalized, balanced, and sustainable eating plan is always the most recommended course of action. The mystery of its creator may never be fully solved, but the impact and lessons learned from the Cabbage Soup Diet's journey through popular culture are undeniable.
