The goal is to create a well-structured and efficient data schema that minimizes data duplication.

Physical Database Design

This stage translates the logical design into a specific DBMS implementation. Key considerations include:

1. **Choosing a DBMS:** Selecting the appropriate database system based on performance, scalability, cost, and feature requirements.
2. **Indexing:** Creating indexes on columns that are frequently used in query predicates or joins to speed up data retrieval. Proper indexing strategies are crucial for performance

optimization.

3. **Partitioning:** Dividing large tables into smaller, more manageable pieces for improved performance and manageability.

5. **Security testing:** Verifying that access controls and other security measures are effective.
